Our commitment to community support remains steadfast, with more than \$250,000 contributed to local groups and over \$1.3 million spent with local contractors and suppliers. These efforts reinforce our position as a cornerstone of the Yarrawonga Mulwala community.

Financial Performance and Future Direction

The financial results are detailed within the Finance Manager's Report; however, it is pleasing to note that the Club recorded an operational profit of \$2,019,028 this year, compared with a profit of \$2,415,895 last year (which included \$700,000 in government grants).

In my first seven months, I have undertaken a full financial and organisational review and implemented a new organisational structure. This has established a strong and dedicated leadership team, excited about contributing to the future success of the Club. We have successfully renegotiated key partnership arrangements, secured improved insurances, and implemented new systems and policies to support staff and operations. In addition, a member survey has recently been conducted, with the valuable feedback to inform the upcoming strategic planning process to be undertaken by the Board and senior management later this year.

Highlights

In March 2025, the Club proudly hosted the IWWF World Show Ski Championships, welcoming teams from Australia, Canada, Belgium, and the USA. The event was an outstanding success, attracting thousands of spectators to the Max Kirwan Ski Park and bringing significant economic benefit to the region with more than 250 competitors and officials in town for over 10 days. Australia placed second overall, an achievement made all the more special with several local team members contributing to the national team's success.

I extend sincere thanks to Peter O'Neill and the Ski Club team members and volunteers, whose dedication and countless hours ensured the success of this event. The commitment of our staff and Board members was also crucial, and I commend them for their contribution to such a significant occasion.

Notice is hereby given that the 44th Annual General Meeting of the Mulwala Water Ski Club will be held at the Club premises, 156 Melbourne Street, Mulwala, NSW 2647, on Sunday 19 October 2025 at 10am.

- 4. To consider and if thought fit pass the Ordinary Resolution which is set out below in this notice.
- 5. To endorse the Mulwala Water Ski Club is a sporting club for tax purposes, therefore in come tax exempt.
- 6. To deal with any other business of which due notice has been given to members.
- 7. To deal with any other business that the meeting may approve, of which due notice has not been given.
- 8. Election of the Board.

RESOLUTIONS

Ordinary Resolution:

That pursuant to section 10 of the Registered Club Act 1976: a) The members hereby approve expenditure by the Club, to a value not exceeding \$60,000 annually, for the following activities of directors in their service as members of the Club's Board of Directors that may be approved by the Board of Directors from time to time;

(i) The reasonable cost of a meal and beverage for each Director, or senior management officer, before or immediately after, a Board or Committee Meeting on the day of that meeting.

(ii) Reasonable expenses incurred by a Director, either within the Club or elsewhere in relation

to Club business and such other promotional activities as may be approved by the Board.

- (iii) The reasonable cost (including the cost of meal, accommodation and travel) of selected Directors, Managers and their partners attending Clubs NSW meetings, the meetings of other associations of which the Club is a member and meetings or conferences that are of a relevant educational or beneficial nature to the Club.
- (b) The members hereby approve additional expenditure by the Club for the provision of a Club directors' uniform for each Directors as approved by the Board of Directors from time to time.
- (c) The members acknowledge that the benefits in paragraphs (a) and (b) above are not available to members generally but only for those who are directors of the Club.

Explanatory Note for Ordinary Resolution

Ordinary Resolution proposes for members to approve the expenditure by the Club on the matters set out in the resolution and the provision of benefits to directors as set out in the resolution. Please note this resolution is required under the Registered Clubs Act 1976 and is procedural in nature.

Procedural Matters for Ordinary Resolution

- 1. To be passed, the Ordinary Resolution must receive votes from 50% +1 of those members who being eligible to do so vote in person on the Ordinary Resolution at the meeting.
- 2. Only Life Members and financial Full Members (other than Junior Sports members) shall be eligible to vote on the Ordinary Resolution.
- 3. Under the Registered Clubs Act 1976 members who are employees of the Club are not entitled to vote on the Ordinary Resolution.
- 4. Proxy voting is prohibited by the Registered Clubs Act 1976.

- **5.** Amendments (other than minor typographical corrections which do not alter the substance or effect of the Resolution) will not be permitted from the floor of the meeting.
- If the Ordinary Resolution is passed it will take effect immediately.
- **7.** The Board of the Club recommends this Ordinary Resolution to the members.

DIRECTORS' NOMINATIONS

Any eligible Financial Member or Life Members of the Club shall be at liberty to nominate an eligible member to serve as a member of the Board. The nomination, on the prescribed form, shall be signed by the member and their proposer and seconder, and lodged with the Chief Executive Officer no later than 6pm, Friday 19 September 2025.

In accordance with section 55 and 56 of the Constitution, this year four positions as a Director shall be elected. The four elected directors shall hold office for a period of two (2) years.

Nomination forms will be available from the Club's Secretary (Chief Executive Officer) from 7 September 2025.

VOTING

If there is more than the required number of nominations a Ballot shall be conducted at the Club premises at the Annual General Meeting, Sunday 19 October 2025. Membership cards and photo identification must be produced in order to vote.

QUERIES ON THE REPORTS

All questions relating to reports stated in the Agenda should be submitted in writing to the Chief Executive Officer at least 7 days prior to the Annual General Meeting. This will allow sufficient time for information to be gathered or research undertaken.

If questions are not submitted in this manner, the Club may not be able to provide a complete answer at the Annual General Meeting

FROM THE FINANCE MANAGER

Following another strong year of trade, the Mulwala Water Ski Club is proud to report an outstanding profit of over \$2,000,000 for the 2025 financial year. This was achieved while navigating rising costs and benefiting from the completion of several major capital upgrades in 2024.

The Club experienced robust growth across multiple areas of the business, with the Bar recording a 7% increase in revenue, Gaming an 8% increase in revenue, and the Holiday Park a 4% increase in revenue thanks to an increase in occupancy throughout the year.

The strong financial result has allowed the Club to further build its financial strength and these reserves will be reinvested back into our Club to further enhance our member and guest experience.

The Mulwala Water Ski Club proudly remains a cornerstone of the local community, providing more than \$250,000 in funding to health groups, sporting clubs and other community groups throughout the Yarrawonga Mulwala region. In addition, more than \$1,300,000 was spent with local contractors, suppliers and entertainers, keeping vital funds in our twin towns.

Our members continue to enjoy the rewards of their loyalty, with over \$760,000 in discounts provided through our Members Rewards program, and over \$740,000 in prizes and promotions distributed throughout the year. Combined, these benefits delivered more than \$1,500,000 back to our members.

In March, we had the pleasure of hosting the 2025 IWWF World Water Ski Show Championships at the Max Kirwan Ski Park. The event attracted competitors and spectators from around the globe and provided a welcome financial boost to Yarrawonga Mulwala.

Finally, I wish to thank our dedicated staff, loyal members and valued guests for your continued support throughout another rewarding year. Together, we look forward to an exciting future for the Mulwala Water Ski Club and our community.

Company secretary

The Company's secretary is Mr Gregory Roberts, who was appointed on 6 January 2025. Mr Roberts is the Company's Chief Executive Officer. Mr Peter Duncan was the Company's secretary and Chief Executive Officer up to 6 January 2025.

Principal activities

The principal activities of the Company during the financial year were that of a water ski club.

There were no significant changes in the nature of the activities of the Company during the year.

Review of operations

The income and expenses for the 2025 financial year have resulted in the net profit of the Company of \$2,019,028 (2024: Profit \$2,415,895).

Significant changes

There have been no significant changes in the state of affairs of the Company during the year.

Dividends

No dividends are payable under the Company's Constitution.

Events subsequent to reporting date

No matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the Company, the results of those operations or the state of affairs of the Company in future financial vears.

Indemnification and insurance of officers and auditors

Indemnification

Since the end of the previous financial year, the Company has not indemnified or made a relevant agreement for indemnifying against a liability any person who is or has been an officer or auditor of the Company.

Insurance premiums

During the financial year the Company has paid premiums in respect of directors' and officers' liability and legal expenses for the year ended 2025 and since the financial year, the Company has paid premiums in respect of such insurance contracts for the year ending 2025. Such insurance contracts insure against certain liability (subject to specific exclusions) of persons who are or have been directors or executive officers of the Company.

The directors have not included details of the nature of the liabilities covered or the amount of the premiums paid in respect of the directors' and officers' liability and legal expenses insurance contracts, as such disclosure is prohibited under the terms of the contract.

Members Liability

The Company is incorporated as a Company limited by guarantee. In accordance with the Memorandum of Association of the Company, every member of the Company undertakes to contribute an amount limited to \$20 per member in the event of winding up the Company during the time he or she is a member or within one year thereafter. The number of members on 30 June 2025 was 13,010 (2024: 12,240).

Going concern

This financial report has been prepared on a going concern basis which contemplates continuity of normal business activities and the realisation of assets and settlement of liabilities in the ordinary course of business. The ability of the Company to continue to operate as a going concern is dependent upon the ability of the Company to generate sufficient cashflows from operations to meet its liabilities.
